Attending the Commissioners were Community Development Director Buddy Sanders, Assistant City Planner Emily Corban and Recording Secretary William Green. The Historic Preservation Commission began the interview process for the Oktibbeha Gardens National Register District Proposals. Community Development Director introduced the interview process stating that each applicant is to be asked 6 questions and rated on a scale of 1 to 10 with a maximum score of 240. The first interview with Terri L. Foley of Historic Preservation Consultants, was done over the phone. The second interview with Tegan D. Baiocchi of GAI Consultants was done in person. The third interview with David Schneider of Schneider Historic Preservation, LLC was done over the phone.

After the interviews were finished, Drew Caves of Watkin Wards and Stafford, collected the forms and tallied the votes. Mr. Caves presented the tallies: Terri L. Foley had a score of 218 GAI Consultants had a score of 207, and Schneider

Historic Preservation, LLC had a score of 221. With the highest score being Schneider Historic Preservation, LLC, the Historic Preservation Commission will send their recommendation of Schneider Historic Preservation, LLC to the October 4, 2016 Board of Alderman meeting.

B. DISCUSSION OF ACTIVITIES RELATED TO OKITBBEHA GARDENS

Commission Chair Fazio discussed the development of a neighborhood organization with Oktibbeha Gardens. Commissioner Hamp Beatty discussed the neighborhood meeting that will be held October 6, 2016 at 5:30 pm in City Hall. The meeting will be an informal informational meeting for neighborhood residents about the process of applying for national historic designation status. Community Development Director Buddy Sanders announced he will notice the meeting as a public work session.

C. UPDATE ON INTERACTION WITH THE STARKVILLE DOWNTOWN ASSOCIATION WITH REGARDS TO THE CREATION OF DESIGN GUIDELINES

Commission Chair Fazio discussed his meeting with Jennifer Gregory of the Downtown Partnership. She is putting in a proposal for grant funds to prepare some downtown design guidelines. He discussed hiring the Design Center on campus to do the guidelines. Mrs. Debra Shaffer has offered to donate her time to do the color palate for downtown. He hoped the Commission would do the signage for downtown.

D. UPDATE ROSTER AND REAPPOINT TERMS

Buddy Sanders discussed the Historic Preservation Commission members whose terms have expired. Jason Barrett noted he would like to seek reappointment. Tom Walker stated he needed time to think about his renewal.

E. PLANNER'S REPORT

This Thursday at 5:30 PM the consultants working on the Starkville Comprehensive Plan will present the fourth draft of the comprehensive plan.
